1. INTRODUCTION:

- 1.1 The Government of Maharashtra has established "ADMISSIONS REGULATING AUTHORITY AND STATE COMMON ENTRANCE TEST CELL" as per the provisions of Maharashtra unaided private professional Educational Institutes (Regulation of Admission & Fees) Act. 2015, (herein after the Act).
- 1.2 Competent Authority- The Commissioner of State CET Cell, has been designated as Competent Authority for selection of candidates for admission to various Homoeopathy Post graduate courses for the year 2024-2025. The AIAPGET 2024 is applicable for admission to Private Unaided Homoeopathy Colleges/Minority institutions. The Commissioner, State CET Cell will conduct the Centralised Admission Process (CAP) 2024-2025 and will prepare the merit list of the AIAPGET 2024.
- 1.3 **Nodal Officer** Director Ayush, Mumbai will act as a Nodal Officer to advice and assist this admission process.
- 1.4 Government of Maharashtra has published the admission rules for Private Unaided Ayurved, Unani and Homoeopathy Post graduate courses vide Gazette Notification No.CET 3516/CR.171/16/Edu-2, dated 06th Oct.2016. The Amendments made by Government of Maharashtra to the rules from time to time shall be followed in respective year of admission.
- 1.5 Central Council of Homoeopathy amended PG Homoeopathy regulations Notification No.12-11/2010-CCH (Pt.II)(1), dt.14-12-2018 and National Commission for Homoeopthy, New Delhi Gazette Notification No. 3-42/2021/NCH/ HEB /PG.Reg. dated 18-03-2024 and the NCH guidelines from time to time.

2. ELIGIBILITY:

- 2.1. The candidate must be an Indian National. Nationality Certificate issued by District Magistrate or Additional District Magistrate or Chief Metropolitan Magistrate or valid passport or School Leaving (SSC) /Jr. College Leaving Certificate of HSC/12th Std. indicating the nationality of the candidate as "Indian" shall constitute the proof of nationality.
- 2.2. A candidate who has passed final B.H.M.S. Examination or equivalent qualification in Homoeopathy included in the second schedule to the Act and passed the qualifying examination from any of the colleges within state of Maharashtra (for State quota seats), and have completing one year compulsory rotatory internship on or before the day **as specified by NCH / GOI from time to time**, are only eligible.
 - 2.3 The Candidate who are passed BHMS degree from the recognised Institute situated out of Maharashtra state and domiciled in the state of Maharashtra are eligible. Such candidates should submit the Domicile Certificate of Maharashtra State by virtue of residence.

- 2.4 The Candidate who are domiciled in the state of Maharashtra and who have obtained admission under 15% All India Quota for BHMS course in the Homoeopathy Medical College situated outside Maharashtra state and who have obtained the degree from a University situated outside the state of Maharashtra will also be eligible for selection process. Such candidates should submit certificate from Dean / Principal of respective Homoeopathy Medical College stating that the Candidate was admitted in 15% All India Quota and Candidates Domicile Certificate of Maharashtra State by virtue of residence.
- 2.5 Candidate under General category and EWS category should have obtained minimum 50th percentile or more marks in AIAPGET 2024 and 40th percentile in case of constitutional reservation. Person with disabilities with General Category and EWS category must secured not less than 45th percentile marks in AIAPGET 2024 examinations.

The above eligibility criteria may change as made applicable as per the decision given by Govt. of India, AYUSH MINISTRY from time to time.

- 2.6. Bachelor of Homoeopathic Medicine and Surgery or equivalent qualification in Homoeopathy included in the second schedule to the Act after undergoing a course of study of not less than 2 years duration (Graded B.H.M.S. degree).
- 2.7. No candidate shall be admitted to M.D. (Hom) course unless he possesses the degree of :-
- Bachelor of Homoeopathic Medicine and Surgery or equivalent qualification in Homoeopathy included in the Second Schedule of the Act, after undergoing a course of study of not less than five year and six months duration including one year compulsory internship; or
- (ii) Bachelor of Homoeopathic Medicine and Surgery (Graded Degree) or equivalent qualification in Homoeopathy include in the Second Schedule of the Act, after undergoing a course of study of not less than two years' duration (alongwith six month compulsory internship).
- 2.8 The candidates must produce the Permanent Registration of M.C.H or proof of application for registration at the time of Document Verification process. Candidates from ALL INDIA QUOTA should produce either Permanent Registration or proof of application alongwith Fee receipt for Permanent Registration with MCH (Refer Rule No.7.1 (xiv).
- 2.9 **Minority Quota: The minority community candidates from within the state are eligible to claim for this quota.** Minority candidate should fill the relevant box indicating the minority category in the application form. Eligibility criteria of minority students will be verified. Admission will be done as

per merit from the eligible Minority candidates as per the status of minority institutes.

Minority candidates shall submit school leaving certificate stating their minority status and produce minority certificate from their respective specific religious place and affidavit stating their minority status along with other original certificates mentioned in Rule No.7.1 in the Brochure.

A candidate must claim the minority in the original application form, failing which the minority claim shall not be granted.

3. APPLICATION PROCEDURE

- 3.1. The Competent Authority shall issue Notification regarding online application form process. An Applicant appearing for admission to Post Graduate Homoeopathy courses through AIAPGET 2024 will be required to submit online Application form and Security deposit. Application form will be available at https://cetcell.mahacet.org
- 3.2 Fees of online application form for **admission to Post Graduate Homoeopathic Courses** through AIAPGET 2024 is Rs. 3000/- and applicable Bank Charges. This application fee is not refundable, hence candidates are advised to go through the Information Brochure and ascertain the eligibility before paying fee. It is sole responsibility of candidate to ascertain online payment of fees within prescribed period, failing which online application will be rejected.

Along with Application form fee of Rs. 3000/- and applicable Bank Charges, each and every candidate will have to pay Refundable Security Deposit as shown in the following table.

Candidate paying deposit as per column (1) will be allowed to fill preferences of Government Institutes only. Candidate paying deposit as per column (2) will be allowed to fill preferences of all the institutions i.e. Government /Government Aided Institutes and Unaided Private / Minority institutes. Candidate should decide well in advance regarding payment of deposit. No extension will be allowed for payment of deposit after the last date of registration.

This deposit will be utilized at the end of Round 3 and subsequent rounds as described below and as shown in **Table 2**.

Refundable security deposit will be refunded at the end of the admission process of AIAPGET 2024 to the same account/card of the candidate from which payment had been made. It is responsibility of the candidate to ensure that the account/card is active until refund process is over. Any request for changing of account/card details for refund will be rejected. This is applicable to those candidates who have joined the allotted college or if candidate did not get any seat during the entire process of counselling.

Refundable Security Deposit will be forfeited where:

- A candidate has been allotted a seat in Round 2 & Round 3 or subsequent rounds and does not report at allotted college to complete the admission process, **or**
- A candidate has cancelled/resigned upto Round 3 or subsequent rounds after joining (Including the candidate who has filled SRF in Round 1)
- If the admission gets cancelled due to any reason e.g. in case the candidate gives wrong information at the time of registration on the basis of which a seat may be allotted and later cancelled by the admission authorities at the time of reporting or fails to produce the required documents at the time of admission.

If deposit of a candidate is forfeited at the end of Round 2, such a candidate if wishes to participate in Round 3 and further Round(s), he/she will have to register again for Round 3 by paying Application form fee of Rs. 3000/and applicable Bank Charges, and the necessary deposit as stated in Table 1.

3.3 Online application Form will be made available and will be notified in due course by State CET Cell. Before filling Online Application form, candidate should download Information Brochure of AIAPGET 2024 and read the same carefully. The Applicants must possess the required criteria and educational qualification as mentioned in the Information Brochure of AIAPGET 2024.

4. PREPARATION OF MERIT LIST

The Competent Authority will prepare the merit list as per AIA-PGET rank and guidelines given by NCH, CCH in there Gazette Dated 14 Dec. 2018 and dated 18-03-2024 and apply to State CET Cell, Maharashtra. It will published on the official website https://cetcell.mahacet.org Percentile obtained by the candidate at the AIAPGET 2024 will form the basis of selection in the respective categories.

- 4.1. Merit list shall be prepared of only those candidates securing 50th percentile or more marks in AIAPGET 2024 in case of open category alongwith EWS category and 40th percentile or more in case of reservation candidates in AIAPGET 2024, in case of Physically Handicapped category candidates in General category / EWS category must secure not less than 45th percentile marks at AIA-PGET 2024. The Physically Handicapped category candidates declared not eligible by the Special Medical Board shall be treated as a general category student and the pass percentage for such candidates shall be as per the qualifying criteria of student quota (50th percentile for general and 40th percentile for the constitutional reservation).
- 4.2.Merit list will be prepared from those candidates who are appearing in AIAPGET 2024 entrance exam and apply to State CET Cell, Maharashtra.

5. DISTRIBUTION OF SEATS:

5.1 Seats reserved for Economically Weaker Section (EWS) :

As per Government Resolution, General Administration Dept. NRP-4019/ C.R.Mo.31/16-A, No. dt.12-2-2020, ten percent (10%) seats are reserved for the candidates under ECONOMICALLY WEAKER SECTION (EWS), in the Government, Government Aided and Private Institutions. This reservation is not applicable for Minority Institutions and also not applicable to the Candidates who are covered under Constitutional reservation. <u>This reservation will be applicable only if Central</u> **Government / NCH / State Government increases existing seats.**

5.2. DISTRIBUTION OF SEATS UNDER SOCIALLY AND EDUCATIONALY BACKWARD CLASS (SEBC) QUOTA :

As per Govt. of Maharashtra, "SOCIALLY AND EDUCATIONALY BACKWARD CLASS (SEBC) Reservation Act, 2024", 10% seats are reserved for the candidates under SEBC category in Government, Government Aided and Private Unaided educational institutions. This reservation is not applicable for Minority Institutions and also not applicable to the Candidates who are covered under constitutional reservation. The reservation for SEBC category will be subject to final decision of the Hon'ble High Court, Mumbai in Writ Petition No.3468/2024.

5.3 DISTRIBUTION OF CONSTITUTIONAL RESERVATION SEATS.

The candidates desirous of claiming the constitutional reservations must have claimed the same in the original application form of AIA-PGET - 2024, failing which the claim will not be entertained subsequently. For detailed information see

Annexure-A.

The distribution of seats at the disposal of Competent Authority will be made by taking into consideration the constitutional reservations shall also be made available on website. Candidates who are domicile of Maharashtra and belongs to backward class from Maharashtra State, are eligible for claiming seat under reserved category. Constitutional reservation in all private Unaided colleges will be as per **Annexure-A**.

5.4 DISTRIBUTION OF SEATS IN PRIVATE MINORITY COLLEGES :

In private unaided Institution 15 % seats shall be reserved for Institutional Quota and 15 % seats shall be reserved for All India Quota and remaining 70% seats shall be reserved for State Quota and these 70% Seats shall be allocated to Minority Quota which shall be filled by Competent Authority from Minority Category Students on merit of AIA-PGET - 2024. If Minority Students not available then that seats shall be filled by General Merit of AIA-PGET - 2024.

The Candidates having Candidature mentioned in sub rule (1), (2) and, (3) of Rule 7 of the gazette shall be eligible for these seats, as per SCHEDULE, if applicable;

5.5.1. State Quota Seats - 70 % state quota seats will be filled by Competent Authority through AIA-PGET - 2024 Merit list.

5.5.2. All India Quota seats : As per Notification dt.14-12-2018 published by Central Council of Homoeopathy, New Delhi, fifteen percent (15%) seats in the Government and Private Institutions shall be reserved for the ALL INDIA QUOTA. Seats under this quota will be filled by the Authority designated by Central Government as per guidelines given by National Commission for Homoeopathy, Ministry of AYUSH, Govt. of India, New Delhi. (Visit website: <u>https://cetcell.mahacet.org</u>).

5.5.3. Institutional Quota seats :

15% Institutional Quota seats shall be filled by State Counselling Authority as per guidelines given by National Commission for Homoeopathy, Ministry of AYUSH, Govt. of India Dated 18-10-2022 through AIAPGET - 2024 Merit list. All eligible candidates from the State and on All India basis can be admitted on AIA-PGET - 2024 merit as per the Gazette Notification No.CET 3516/CR.171/16/Edu-2, dated 06th Oct. 2016 and amendment made by NCISM/AYUSH time to time.

6. PREFERENCE FILLING PROCESS.

The candidates will give their preferences through online which will be notified by the Competent Authority on website https://cetcell.mahacet.org. The schedule, seat distribution and procedure regarding preference form filling process and details of further admission process will be made available to the eligible candidates in the preference form brochure and on the website. The selection to a course/college will be made considering his/her Final State Merit List Number and preferences given by the candidate. Seat allocation shall be made centrally at a later date on the basis of AIA-PGET- 2024 Final State Merit List (SML) number and preferences exercised by the candidate.

- 6.1 Candidates should download copy of preference form brochure and read the same carefully. The candidate should fill online preference form.
- 6.2 At the time of Document verification process the candidate should bring all original documents and a set of attested copies of the same in support of claim made in application form i.e. Caste Certificate, Caste Validity Certificate, and Non-Creamy layer Certificate.
 - 1. **The Subject & College combination code** is a five digit number specific for each college & Subject combination. Candidate can fill minimum one preference and maximum 120 preferences only. It is not compulsory to fill all Preferences. The first digit of the code number indicates Character of the College, next two digits of the code indicate specific college / institution and last two digits indicate particular subject.

For Example :

2. College & Subject codes are given to courses existing in these colleges. For some of these codes the seat(s) may not be available for postgraduate seats during Round-1. In the subsequent rounds, some seats may become available. Therefore, candidates who desire to opt for these seats can exercise the preference in the preference form for these seats considering eventuality of availability of such seats.

Candidate should read all instructions before he / she starts filling the online preference form. Candidate should fill carefully the subject & college combination codes.

- 3. Candidate should fill his most preferred college and subject combination code as Preference No.1 followed by his next choice as No.2 and so on. While filling the college and subject combination code number should be written in boxes.
- 4. The same subject and college combination code should not be filled more than once. In case the candidate fills same code more than once, its higher Preference number will be considered and subsequent repeated number will be ignored. If the candidate fills wrong code number it will not be considered.
- 5. Candidate should note that the Preferences of subject and college combination codes, once entered in the online form, after verification by the candidate, shall be final and irrevocable. Thereafter there cannot be any change, addition or deletion of Preferences entered by the candidate.
- 6. If a candidate gets selected for a particular M.D. (Hom) in Homoeopathic courses, then the candidate is required to join that course as per the procedure.
- 7. For filling of vacant seats after first round, fresh preferences will be considered for subsequent computerized rounds. Vacant seats will be published before each round.
- **6.3 Seat distribution chart:** The seat distribution chart for AIA-PGET 2024 is made available on www.mahacet.org contains distribution of available seats. The college-wise, subject-wise and category-wise distribution is also available on website. It should be noted that category candidates are eligible and can avail open merit seats by virtue of merit. Category seats, if at all remain unclaimed by a particular category candidate are made available to other categories & to open category candidates as per inter-se category round procedure. Seat distribution chart may be change subject to permission or approval given by NCH / Transfer of PG Teacher /affiliation from University as case may be.
- 6.3.1 All the College and Courses are affiliated to The Maharashtra University Health Sciences, Nashik .

6.3.2 If a candidate does not give preference for a particular code Private and Minority Colleges; then it means that he / she is not interested / desiring to take that PG seat.

7. DOCUMENT VERIFICATION AND SELECTION PROCESS :

The Candidate will have to report at the time of admission in the allotted college with his / her original documents for physical verification and admission. The Candidate should report personally (Proxy not allowed) to the respective allotted college, for the physical document verification and admission. The College Authority / Principal give the admission to the candidate if he / she found eligible after document verification.

At the time of Document verification process / admission the candidate should bring **all original documents and a set of two attested copies** of the same in support of claim made in application form i.e. Caste Certificate, Caste Validity Certificate, Non-Creamy Layer Certificate etc.

 - 3) Such category candidates without validity and / or NCL, who are considered as Open Merit candidate.
 - 4) **Applicants belonging to SBC:** The Candidate belonging to Special Backward Class (SBC) are to be considered as OBC candidates and such candidates will be required to produce Non- Creamy Layer Certificate.
 - 5) Applicant belongs to Jain Minority: (a) The person belonging to Jain minority must produce School leaving certificate stating that Candidates belongs to Jain minority and / or Certificate from Religious place (Temple) that he / she belongs to Jain Minority
 - (b) Affidavit stating that he / she belongs to Jain Minority.
 - 6) Applicant belongs to Gujrathi Minority: (a) The person belonging to Gujrathi minority must produce School leaving certificate stating that Candidates belongs to Gujrathi minority. In case there is no entry of Gujrathi minority on school leaving certificate, he / she should bring the Certificate of Head Master / Principal of that School / College certifying that he/she belongs to Gujrathi minority. and
 - (b) Affidavit stating that he / she belongs to Gujrathi Minority.

For admissions under All India Quota 15% (AIQ) – Rules for admission and Original Documents alongwith two set of self attested photocopies are required as per Information Bulletin and Counselling Scheme, Ayush admissions Central Counselling Committee (AACCC), Ministry of AYUSH, Government of India, New Delhi. (Visit website: <u>www.aaccc.gov.in</u>).

7.2 For Constitutional reservation category candidates: Ear-Marking - Reserved category candidate entitled to admission on the basis of merit in an open category seat will have the option of taking admission either against his/her respective category seat or on an open category seat. If he/she opts for the reserved category he/she will be deemed to have been admitted as an open category candidate and not as reserved category candidate. One seat in the college where he/she was eligible for admission against open

seat shall be earmarked for a candidate belonging to the respective reserved category. Such earmarked seat will be made available immediately to the successive reserved category candidate from the same category merit.

8. ONLINE PREFERENCE FILLING AND SELECTION PROCESS: There will be Preference form filling for Round-1, Round-2, Round-3 and Online Stray Vacancy Round separately. For each round candidate can fill online Preference form multiple times before clicking submit button. Once submit button is clicked, there is no provision to change the preference(s). These preference(s) filled for each round will be used for selection of respective round only. Online preferences filled for Online Stray Vacancy Round will be used for subsequent Online Stray Vacancy Round(s) (if any).

CAP Round-1 Process:

- If the candidate joins his/her Round-1 seat and wants to upgrade his/her allotted seat, then he/she shall NOT fill Status Retention Form and will have to fill fresh choice(s) for Round-2.
- If a Candidate joins and is satisfied with the seat allotted in Round-1 and is not willing for up-gradation in Round-2, he/she can fill Status Retention Form. Such a candidate will not be considered for any of the further round(s) during the admission for the academic year. However, such a candidate can resign from the allotted seat before the prescribed/stipulated date and such a candidate will be eligible for Round-2.
- If the candidate is selected in Round-1 of counseling and does not report at the allotted institute, such a candidate will be eligible for Round-2. No new registration is required. Such a candidate may participate again in Round-2 after logging in with their earlier Registration details and filling fresh preference(s). His/her selection of Round-1 stands cancelled. The seat so allotted to such a candidate who does not join, will be presumed to be a vacant seat as on the last date of joining and from the next date after the date set out as the last date for joining the college in terms of such allotment. Such a vacant seat will be allotted in Round-2 of the admission process.

CAP Round-2 Process:

Available Seats for Round-2:

- Seats not allotted during Round-1.
- Seats vacant due to non joining / cancellation by candidate(s) allotted in Round-1.
- Seats available due to upgradation of candidate(s), who have been allotted during Round-1 and joined the seat.

Following types of Candidates are eligible for seat allotment in Round-2:

- ✓ Registered candidates who did not fill choices in Round-1.
- ✓ Registered candidates who participated in Round-1 but did not get any seat allotted in Round-1.
- ✓ Registered candidates, whose seat allotted in Round-1 got cancelled during the document verification due to his/her invalid/wrong claim on reporting for admission to the selected Institute, but candidate is otherwise eligible for selection with change in the invalid/wrong claim. For such a candidate, selection during first round will not be

valid and he/she will be eligible only on available seats during second round with corrected claim.

- ✓ Candidates who have reported/joined at allotted institute during the joining period of Round-1 of allotment and did not filled Status Retention Form.
- ✓ Candidate who does not join the allotted seat during Round-1.
- Candidate who has joined and resigned upto the prescribed last date of joining Round 1.
- Candidate will have to fill fresh choices for Round-2. Round-1 choices will be considered as null & void. If a candidate is not interested to participate in Round-2, he/she should not fill preferences for Round-2 and such a candidate who has joined during Round-1, will have his/her Round-1 seat allotted status.
- The allotment of seat for Round-2 will be as per the merit and preference(s) filled by the candidates for Round-2.
- If a candidate joined during Round-1, is upgraded in Round-2 (as per his/her preference(s) submitted during Round-2), his/her allotted seat of Round-1 will be available in Round-2 and allotted to another candidate as per merit in the same round.
- If a candidate joined during Round-1 and is not upgraded in Round-2 (i.e. no seat is allotted during Round-2), will have his/her Round-1 seat allotted status.
- Candidate allotted a seat during Round-2, if does not join the allotted seat, his/her Security deposit will be forfeited. Such a candidate will be eligible for Round-3 only after fresh registration and Security deposit as per Table-2.
- If the candidate joins his/her Round-2 seat and wants to upgrade his/her allotted seat, then he/she shall NOT fill Status Retention Form and will have to fill fresh choice(s) for Round-3.
- If a Candidate joins and is satisfied with the seat allotted in Round-2 and is not willing for up-gradation in Round-3, he/she can fill Status Retention Form.

✓ **Following types of Candidates are not eligible for seat allotment in Round-2:**

- Candidates who have joined Round-1 allotted seat and filled Status Retention Form.
- Candidates who have not filled fresh preferences for Round-2.
- If a candidate is selected during Round-2, he/she will have to join the college / seat allotted during second round. After joining the allotted institute in Round-2 the candidate will be eligible for upgradation in Round-3 as per merit.
- If a candidate does not join the selected seat during Round-2, he/she will be eligible for further round(s) of selection only after registering again for Round-3 by paying online registration fee (non refundable) and Security deposit as per Table-2.

CAP Round-3 Process:

- ✓ <u>Available Seats for Round-3:</u>
- Seats not allotted during Round-2.
- Seats vacant due to non-joining / cancellation by candidate(s) allotted in Round-2.

Following types of Candidates are eligible for seat allotment in Round-3:

- Registered candidates who did not fill preferences in Round-1 & Round-2.
- Registered candidates who participated in Round-1 & Round-2 but did not get any seat allotted in Round-1 & Round-2.
- Candidates allotted and joined seat in Round-1/Round-2 & not filled Status Retention Form.
- Candidates who have registered in Round-3.
- Candidate will have to fill fresh preferences for Round-3. All previous preferences will be considered as null & void.

✓ <u>Candidates not eligible for Round 3:</u>

- Candidates who have joined seat in Round-1/Round-2 of State Quota seats and filled Status Retention Form.
- Candidates who have been allotted a seat in Round-3 of All India Quota seats of AACCC and Round 2 of All India Quota seats of State CET Cell.
- If a candidate is allotted a seat during Round-3 he/she will have to join the college / seat allotted during that round and will not be eligible for subsequent round(s) of State Counseling Process.

Subsequent Round(s):

After Round-3, subsequent Online Stray Vacancy Round(s) will be conducted if seat(s) remain vacant.

Online CAP Stray Vacancy Round Process:

Available Seats for Online CAP Stray Vacancy Round(s):

- Seats not allotted during Round-3.
- Seats vacant due to non-joining of candidate(s) allotted in Round-3

Eligible Candidates:

• Candidate who have registered & filled online preference form previously but not been allotted a seat till Round-3.

Not Eligible Candidates:

- Candidates who **have joined seat** in Round-1, Round-2 and/or allotted a seat in Round-3.
- Candidates who **have joined seat** in Round-1, Round-2 and/or allotted a seat in Round-3 of **All India Quota seats of AACCC and** Round 2 of All India Quota seats of State CET Cell.

Note –

- No new registration will be done for this Round.
- Candidate will have to fill fresh preferences for CAP online stray vacancy round(s). Round-3 choices will be considered as null & void.
- Allotment of seat will be done Online by running software.
- Seats remaining vacant after Online CAP Stray Vacancy Round will be filled by **Subsequent Online CAP stray vacancy round(s).**

- 9. Status Retention: In case if a candidate to whom a seat has been allotted in the preference form round(s) and who has joined the college accordingly, is satisfied with the allotment, such a candidate must submit a Status-Retention Form (Annexure-G) in the given format on or before prescribed date with the Dean/Principal of the College where such a seat has been allotted to such a candidate. The Dean/ Principal of every Homoeopathy College to which admissions are so made in terms of these rules, may appoint an appropriate Officer to receive such Status Retention Forms. Upon receipt of such Status Retention Forms, an acknowledgement in writing shall be issued immediately the concerned candidates to acknowledge the receipt of such a Status to Retention Form within the prescribed time. It is mandatory for every such candidate submitting a Status Retention Form to insist for issuance of acknowledgement thereof and to preserve such acknowledgement till the present admission process is finally concluded. In absence of such an acknowledgement, the claim of submission of Status Retention Form within the prescribed time shall not be entertained.
- 9.1 Names of all the candidates who have submitted the Status Retention Form as above within the prescribed time and the seats occupied by them will be removed out of consideration for the remaining admission process.

10. PAYMENT OF FEES : Fees for Private Unaided and Minority College for the course should be paid as per decided by Fee Regularity Authority, Mumbai.

11. Refund of Fees / Cancellation of admission by Institutions.-

- (a) If the admission is cancelled or change of college during any round at any time before last CAP round declared by Competent Authority, the processing fee of Rs.1500/-(Rs. One Thousand Five Hundred only) to be deducted and rest of the fees to be refunded.
- (b) Cancellation -

(i) The selected candidate must join the college at which he/she is selected, on or before the date prescribed by the Competent Authority in each round, failing which his/her admission shall stand cancelled.

(ii) The selected candidate who has joined the college and desires to cancel the admission should cancel it, at the respective college by filling Application prescribed in the Proforma (**Annexure - H**). The college should accept the cancellation and inform the Competent Authority along with copy of the cancellation letter immediately. Any application for cancellation of admission from the Candidate sent directly to Competent Authority will not be considered.

- (iii) Any candidate who cancels his/her admission and becomes responsible for lapse of Post graduate Homoeopathy seat on or before or after the 'Cut-off date' declared by AYUSH Ministry / NCH, New Delhi in any Private Unaided Homoeopathy college for whatsoever reason, will have to pay penalty of Rs. 3,00,000/- (Rupees Three Lacs Only) (inclusive the fees paid by the Candidate at the time of admission) to the concerned college before being relieved from the college.
- 12. Their shall be no admission of any student in respect of any academic session beyond 'Cut-off date' as specified by Ministry of Ayush / NCH for Postgraduate course under any circumstances. The University shall not register any student admitted beyond the said date.

13. CONDUCT AND DISCIPLINE

- 13.1. The candidates admitted in any other subjects other than clinical subjects through this process shall have to compulsorily work in the clinical departments as Residents/House Officers/Registrar for at least two years. All these Homoeopathy Colleges where the strength of Postgraduate students in Clinical Subjects is less, it shall remain the prerogative of the Principal of the Institute to utilize the services of such Postgraduate Degree Students of Non-clinical subjects for Clinical Departments even for the third year. Principal's decision in this regard shall remain final. Candidates selected for clinical subjects will have to work as Residents/House officer or Registrar, in the same subject for the full term of three years or till the completion of his PG Course, whichever is later. If this rule is not followed, it would result in cancellation of candidate's registration to PG Course. All Diploma candidates shall have to essentially work in Clinical Departments for a period of one year.
- 13.2. A candidate admitted to any Post-graduate Homoeopathy Course will not be allowed to work in any other institute or will not be allowed to work as a Homoeopathy practitioner in his own /private/aided/ non-aided or any other type of dispensary or hospital or any other institute.

The registration once granted is only valid if the respective Postgraduate Guide and the Principal are satisfied about regularity, diligent persuasion of studies by the student as well as good conduct. An absence of 2 months or above from the Institution without assigning any genuine and satisfactory reason would automatically amount to cancellation of the registration of the candidate to PG Course. The concerned Principals shall take such decision and simultaneously communicate to the concerned university and also to the Competent Authority. Inaction on the part of Principal shall amount to violation of rules and authority shall propose a reasonable action to the University.

- 13.3 The student while studying in the Postgraduate Homoeopathy Courses, if found indulging in antinational activities, unlawful activities or ragging in any form, contrary to the provisions of Acts and Law enforced by Government, will be liable to be expelled from the college by the Principal of the College.
- 13.4 Failure of the candidate in making full and correct statements in the application form and/or suppression of any information would lead to disqualification of the candidate, even at later date. Such a candidate will be debarred from the entire selection process.
- 13.5 It is responsibility of every candidate to submit proper documents. Any attempt to submit documents, which are not genuine, will lead to cancellation of the admission of the candidate, forfeiture of the fees, deposits and expulsion of the candidate from the college by the Competent Authority or by his Authorized official. The name of such candidate/s shall be deleted from the PGH-CET of the respective year Merit List and he/she will not be eligible for further rounds of the selection process and will be debarred from the selection process. If deemed fit even criminal proceeding may be initiated by the Competent Authority against such candidates/their parents.
- 13.6 Pursuant to orders in W.P. (Civil) No. 656 of 1999, Hon'ble Supreme Court of India, has directed the Department of Human resources Development and Education, Govt. of India, to take all necessary steps to curb the menace of ragging and take severe action against the students involved in such activities.
- 13.7 As per the provisions of Maharashtra Act XXXIII known as "Maharashtra Prohibition of ragging Act of 1999", students indulging in ragging can be punished under the Act resulting in suspension, expulsion from the college and imprisonment.
- 13.8 Any issue not dealt here in above will be dealt with, when arising, fully and finally by the Competent Authority, State CET Cell, Mumbai. Any amendments made by Government of Maharashtra/Central Government / Ministry of Ayush / National Commission for Homoeopathy / Hon'ble Supreme Court and Hon'ble High Court from time to time will be implemented.

- 2) Candidates belonging to aforesaid Backward Class categories will be required to submit the Caste Certificate and the Caste/Tribe Validity Certificate at the time of documents verification.
- 3) Caste certificate issuing authority: Caste certificate stating that the caste is recognized under a particular backward class category in Maharashtra state is issued by Sub-Divisional Magistrate/Executive Magistrate/Metropolitan Magistrate in Maharashtra state.
- 4) The Caste/Tribe validity Certificate issuing Authorities are as follows:-

a) For Candidates belonging to Scheduled Caste, Scheduled Caste converts to Buddhism, Vimukta Jati -A, Nomadic Tribes - B, C, D, Other Backward Class and **Socially and Educationally Backward Classes (SEBC)**. Caste Validity Certificate is issued by **Divisional Caste Certificate Scrutiny Committee of respective Divisional Social Welfare Office** (Konkan, Pune, Nashik, Aurangabad, Amravati and Nagpur).

b) For Candidates belonging to Scheduled Tribe the Tribe Validity Certificate is issued by Director/Deputy Director, **Tribe Certificate Scrutiny Committee of respective Region** (Konkan, Pune, Nashik, Aurangabad, Amravati and Nagpur).

5) The candidate should have claimed the constitutional reservation in the original application form. The candidate claiming constitutional reservation must submit original Caste Validity Certificate at the time of document verification / admission, failing which the category claim will not be granted and he / she will be treated as general candidate provided that he/she should fulfils the eligibility conditions of general category candidate.

6) NON-CREAMY LAYER

A candidate belonging to 'Creamy Layer' amongst the categories (C) to (G) must note that the provision of reservation is NOT applicable to him/her. A candidate claiming benefit of reservation under the categories (C) to (G) above will be required to produce Non-Creamy layer certificate as specified in the Government resolution CBC-10/2008/CR-697 VJNT-1, dated 24th June, 2013. The certificate should have **valid upto 31/03/2025.** The Non-Creamy Layer Certificate is issued by Sub-Divisional Officer/Deputy Collector/Collector of the district.

However, such a Non-Creamy Layer Certificate shall be produced in any case at the time of document verification / admission; failing which the category claimed will not be granted and he / she will be treated as general candidate provided that he/she should fulfils the eligibility conditions of general category candidate.

Applicants belonging to Special Backward Class

N.B.: Hon'ble High Court Mumbai had stayed admission to SBC category as a separate quota and therefore, vide Government Circular from Social Welfare, Cultural Affairs and Sports Department No. CBC-1095/WS/264/BCD-5 dated 24th October 1995, the persons belonging to Special Backward Class (SBC) are to be considered as OBC candidates.

7) Inter-se amongst the reserved categories will be operated at the end of each admission process against the unfilled reserved categories seats as per merit and choice of the reserved categories candidates.

- (b) If the seats still remain vacant, then the seats will be filled, from among the candidates of all the categories mentioned above from the all categories combined merit list.
- (c) If the seats still remain vacant then the seats will be filled from among the candidates of the common merit list.
- (d) If the seats remained vacant from SEBC category and EWS quota then the seats will be filled from general category candidates.
- 8) **Ear-Marking :** Reserved category candidate entitled to admission on the basis of merit in an open category seat will have the option of taking admission either against his/her respective category seat or on an open category seat. If he/she opts for the reserved category he/she will be deemed to have been admitted as an open category candidate and not as reserved category candidate. One seat in the college where he/she was eligible for admission against open seat shall be earmarked for a candidate belonging to the respective reserved category. Such earmarked seat will be made available immediately to the successive reserved category candidate from the same category merit.

Admission under constitutional reservation seat will be governed by the Maharashtra Schedule Castes, Scheduled Tribes, Denotified Tribes (VimuktaJatis), Nomadic Tribes, Other Backward Classes and Special Backward Category (Regulation of Issuance and Verification of) Caste Certificate Act, 2000 (Mah. Act No. XXIII of 2001).
