Online Choice Filling & Schedule for Online Stray Vacancy Round-5

Ref - National Commission for Indian System of Medicine, Ministry of AYUSH, Letter dated 20/12/2024

The Online Stray Vacancy Round was completed on 20/12/2024, at the end of the round there are a few seats remaining vacant for PG Ayurved & Homoeopahty courses. It is noted that many candidates who had been allotted a seat did not take the seat which has resulted in vacancy.

Vide above referred letter from NCISM, Ministry of AYUSH has extended the cut off date of admission from 20/12/2024 to 31/12/2024. Hence in view of the extension of cut off date of admission for AYUSH courses by respective central council, the competent authority has decided to conduct subsequent rounds of counselling as per the schedule given in Table 1 below.

It is noted that many candidates fill the preference but when allotted do not report to the college resulting in vacancy and subsequent lapse of seat. Hence to avoid such situation the candidates are advised to follow the below mentioned instructions before participating in the process

- 1. There will be fresh choice filling for this round(s), all the previous choice/preferences filled will be null and void.
- 2. It is mandatory to join the allotted seat in this round. If any candidate fails to join the allotted seat action may be taken against them for lapse of seat. Hence candidate must be vigilant while filing the choices.
- 3. Only those candidates who are eligible for this round can fill the choices and will be considered for allotment.
- 4. The candidates should be vigilant while filling the preferences and should fill only those preference where they are interested in joining.
- 5. The candidates should ascertain the fees and other requirements from the colleges prior to filling the preference.
- 6. The candidates are expected to enquire about facilities at the college including hostel, food, transport etc well in advance before filling the choice for that particular college.
- 7. Fees for all the private colleges are given on website of Fees Regulating Authority and the fees of IQ will be 3 times the fees for OPEN. Candidates should get acquainted with the fee structure of the college before filling the choice for that college.
- 8. This choice filling is one time measure taken by the Competent authority in order to allot the seats to the deserving candidates who wish to take the seats and hence candidates should be vigilant before filling their preferences.
- 9. No change in the preference will be allowed after the given schedule.
